INTRODUCTION

1. We have examined the financial statements of EUROATLANTIC AIRWAYS – Transportes Aéreos, S.A., comprising the Balance Sheet as at 31 December 2013 (which show total assets of 101 172 041 Euros, and a total of 12 594 027 Euros in the equity, including a net profit of 3 753 273 Euros), the income statement and the cash flow statement for the year then ended, the statement of changes in equity and the accompanying notes.

 - The assessment whether the presentation of the financial statements is adequate;
